- ii Landscape report Work was completed. We had 60 piles total at a cost of \$3,520. Neighborhood response was positive. The committee believes the green-waste pickup can be an annual event each Spring.

c. Business Process Committee

- Road Finance Subcommittee The proposed amendment to the Articles of Incorporation to raise the borrowing limit to \$950,000 dollars. The amendment was sent to all 367 homeowners. For the amendment to pass, we need 75% of the entire (367) membership or 276 members in support of the amendment. To date, we have the assent of 213 property owners. If passed, a subsequent vote will be required to borrow the funds necessary to repair or replace our privately own streets.
